

Application for Distribution Guidelines

- 1. You must qualify for the disbursement you are applying for before the deadline rather than by the payment date. For example, if your birthday is in April, you don't meet the proceeding March deadline and will fall into the April through June cycle, which will be paid in September.
- 2. All disbursements require an application and are optional. You will turn in five (5) different applications if you are applying for all disbursements. No payment is made automatically. Each disbursement is optional, and the fund will remain invested until you apply for disbursement.
- 3. You cannot stack distributions. If you are 24, you qualify for the age 24 distribution but not the age 22 distribution. If you are 23, you qualify for the age 22 distribution but not the age 20 distribution. If you are 22, you qualify for the age 22 distribution but not the age 20 distribution.
- 4. You are entitled to a maximum of five (5) distributions. Therefore, if you are 21 and have already received your age 18 and age 21 distribution, you will qualify for the age 22, age 24, and age 25 disbursements in the future but you will not get an age 20 disbursement.
- 5. If you are 20, you qualify for the age 20 distribution, and will later qualify for the age 22, 24, and 25 distributions. If you are 20 and didn't qualify for the age 18 distribution, you can take that distribution now. This is the only exception to the no stacking rule.
- 6. If you received your age 18 and age 21 distribution under the old system, you do not qualify for a back payment of \$25,000 even though the distributions are more than the original distribution amounts.
